No entry fee will be refunded if the trial cannot open or be completed by reasons of riot, civil disturbance, fire, an act of God, public emergency or any other cause beyond the control of the organizing committee. Bitches in season are not eligible to enter Earthdog tests. There will be no refund of any entry in this case.

## **Eligibility and Entry Requirements**

**Eligible Breeds:** Dachshunds and Terrier breeds: Australian Terrier, Bedlington Terrier, Border Terrier, Cairn Terrier, Cesky Terrier, Dachshund, Dandie Dinmont Terrier, Glen of Imaal Terrier, Jagdterrier, Lakeland Terrier, Manchester Terrier, Miniature Bull Terrier, Miniature Pinscher, Miniature Schnauzer, Norfolk Terrier, Norwich Terrier, Parson Russell Terrier, Rat Terrier, Russell Terrier, Scottish Terrier, Sealyham Terrier, Silky Terrier, Skye Terrier, Smooth Fox Terrier, Welsh Terrier, West Highland White Terrier, Wire Fox Terrier, Yorkshire Terrier. Dogs must be 6 months of age and registered with the AKC or have an ILP granted by the AKC. A dog of eligible breed with an acceptable foreign registration number is eligible to participate subject to Chapter 11, Sec. 1 of the Dog Show Rules. Dogs of an eligible breed that have been granted Indefinite Listing Privileges (ILP) are eligible to participate.
