**THERE ARE NO REFUNDS FOR ABSENT DOGS OR IF SECRETARY IS NOT INFORMED PRIOR TO THE ENTERED TESTS FOR BITCHES IN SEASON, OR ILL/UNFIT DOGS**

Early, incomplete, unsigned, conditional,  
or unpaid entries will not be accepted.

You may withdraw your entry PRIOR TO CLOSING and your entry will be refunded, less a \$4.00 per entry fee.

**AFTER PRE-ENTRY CLOSING YOU MAY WITHDRAW YOUR ENTRY ONLY IF YOUR SPACE CAN BE FILLED FROM THE WAITLIST –**

**THERE IS A \$5/ENTRY FEE FOR WITHDRAWAL AFTER CLOSING**

Bitches in season and dogs unfit to participate will have their entry refunded, less any online processing fees.

All eligible refunds will be processed after the conclusion of all the tests.

Entries paid by check can take up to 30 days to refund.

**THERE ARE NO REFUNDS FOR ABSENT DOGS OR BITCHES IN SEASON / UNFIT DOGS IF SECRETARY IS NOT INFORMED PRIOR TO THE TEST DATE.**

Each “test” is a separate event – you may enter up to two tests per day –

For example, you can enter Test #1 AND Test #2 on one day and  
both runs will be assigned to the same block of time.

Dogs entering ONLY ONE test on a single day may be assigned after closing to either Test #1 or Test #2 to balance entry numbers - it will not impact run time

## Prizes

The Club will offer a flat light blue ribbon for a passing qualifying run.

The Club will also offer Rosettes for new titles – please alert the Secretary if you expect to complete a title at this event.

**These will be CONCURRENT Tests using a BLOCK SCHEDULE.**

NO RUN ORDER will be mailed out - a time block will be assigned.

An email explaining the process will be sent out prior to the event.

## ROLL CALL

Tests will run concurrently with rolling check-in and inspection. Plan to arrive at least  
30 minutes prior to your scheduled run block. This is a “show & go” event, we ask that  
you depart the site when you have completed all your runs unless you are available to  
assist other entrants. All dogs must be checked in for at least their first run no later  
than 15 minutes past the start of the final run block of the day.

Every dog must pass through inspection before each run. Dogs who have not been  
inspected for *each* run will not be run. If you do not check in by the start of the last run  
block, we will assume you are absent.

**NO REFUNDS FOR ABSENT DOGS.** At inspection, all dogs will be examined for fitness to run.  
Bitches known to be in season and ill or injured dogs are not to be brought to the test.  
Contact the Test Secretary prior to the event to be eligible for refunds.

**At inspection,** bitches in season, lame and unfit dogs will be excused with entry refunded,  
less any online processing fees.

Early acceptance of dogs for members of the test committee may begin one-half hour  
prior to published test hours.

## Hours

Grounds will be available one hour prior to event hours.

Event hours are from 8:00AM until all runs are completed.

**It is the responsibility of each entrant to be ready with catcher and releaser  
when their dog is called to the line.**

### What is the Fast CAT?

1. Fast CAT is a timed straight 100-yard dash for dogs.
2. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen. The course is completely fenced, and dogs are run individually.
3. Dogs are timed when they complete the 100-yard dash. The time is converted to Miles Per Hour (MPH). MPH is calculated by

### 204.545 divided by the run time (204.545/x=MPH)

4. Based on the dog's size at the withers a handicap is applied and points are earned:

- 18" or greater = Handicap is 1.0
- 12" up to less than 18" = Handicap is 1.5.
- Under 12" = Handicap is 2.0.

### **5. FORMULA: MPH X HANDICAP = POINTS**

6. Titles are earned at specific point levels

BCAT = 150 points, DCAT = 500 points, FCAT = 1,000 points

FCAT# = Each additional 500 points

### \*ACCORDING TO AKC RULES:

- Handlers in FastCAT are not permitted to **travel** down the 100-yard course **during a dog's run or just prior to a dog being released for its run.**
- It is recommended that an owner or someone familiar with the dog stand at the finish in order to catch the dog once the course has been completed. **A handler cannot recall their dog from the start line.**
- Dogs that are physically challenged due to loss of limbs are eligible to enter...For safety purposes, any dog requiring an assistance apparatus, such as a wheeled cart will not be allowed to participate.
- Dogs with artificial coloring in their coats may participate in FastCAT. The coloring must not cover more than one-third of the dog's coat. The coloring must not disperse (leave a cloud) when the dog is running...
- Handlers are not to allow dogs to be enticed through the course with anything other than the lure during its official run. NO mechanical devices including whistles, horns, bull horns, etc. or food or toys including the waving of objects to lure the dog to the finish line. You MAY CHEER and use the dog's name only.
- Head halters, such as the Gentle Leader or Halti, may be used on the grounds but must not be worn while running the course. Dogs may be muzzled at the owner's discretion...Special Training devices that are used to control and train dogs, including but not limited to, **collars with prongs, electronic training devices may not be used on dogs at AKC events.**

### Test Site Directions:

John C Rudy Park – The Meadows Dog Park – entrance on Dellinger Rd.

**From the North:** take 83 South to Exit 24 for PA 238 East. Go .9 miles, turn right onto PA 181 George St. Go .4 miles, turn left onto Emig Rd, then left onto Mundis Race Rd.

**From the South:** take 83 North to Exit 22, PA 181 N George St, go 2 miles, keep right on N181-N. Manchester. Merge onto 181-N George St. Go 1.8 miles, turn right onto Emig Rd, then left onto Mundis Race Rd.

**GPS will take you to the admin office – Dellinger Rd is the left turn before you reach the office.**

Parking for the test is at the Songbird Field. Restrooms located in that parking lot. **No dogs allowed in the pavilion.**

### FUN RUNS:

Fun Runs are **non-official** "practice" runs that are offered – **WEATHER AND TIME PERMITTING AT THE DISCRETION OF THE CLUB and LURE OPERATOR** – after the completion of the official runs on Saturday.

There are no Fun Runs on Sundays.

SIGN UP FOR FUN RUNS AT THIS EVENT CAN BE ONLINE OR ON-SITE DAY OF.

In the event the fun runs are not held/completed based on the Club's decision, fun run fees will be refunded in full. There are NO refunds for missed fun runs; you may sell/give away your **fun run**.

### Test Information

- All entries must be 12 months of age or older on the day of the test.
- Each dog requires an individual entry form for each event in which it is entered.
- ALL DOGS RUN AT OWNER'S SOLE RISK
- Dogs should be warmed up before and cooled down after running.
- The show grounds may not be completely fenced. The FastCAT course will be fenced.
- Dogs must be on lead or crated unless running.
- A \$5 fine will be assessed for any loose dog on the field not competing, or an exhibitor caught not picking up after their dog.
- You are responsible for controlling your dog(s) and children.
- On site bathroom facilities are available.
- The Hunt master is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. He/She has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve the dog on the course.
- Bitches in season and dogs determined unfit at inspection will be excused and their entry fees will be refunded less any online processing fee. No refunds for absent dogs.
- All AKC rules regarding sportsmanship and conduct apply.
- Persons exhibiting conduct detrimental to the AKC / sponsoring Club(s) / dog(s) or person(s) will be asked to leave the event site by the Field Committee, may be disciplined by the AKC, and entry fees will not be refunded.
- No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club.
- York County Dog Training Club, their agents, members, representatives, volunteers, etc., assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.
- **This is a rain-or-shine outdoor event.** Please plan accordingly. Please bring your own shade and chairs.
- Participants are expected to wear shoes that completely cover the foot and provide protection from the lure line.
- After closing, entries may only be changed if they were recorded incorrectly.
- **There are no refunds for absent dogs.** Refunds are only given to bitches in season and dogs unfit to participate determined at inspection or by prior notice to the Secretary.

Dogs who wish to participate in FastCAT must be either an AKC-registered dog or part of the AKC Canine Partners program. Canine Partners is for mixed breeds or dogs who are otherwise ineligible for AKC registration.

Owners can submit a reduced-fee enrollment for the Canine Partners program along with their entry for this event using the form provided.
